### **Agreement on Plant Genetic Resources becomes effective**

The European Union and 9 of its member states joined the agreement on Plant Genetic Resources at the 31st of March 2004. With that, the number of signing countries exceeds 40, which is required to that the agreement may be put into force (now 47 signing countries). Now, the international contract can become effective at the 29<sup>th</sup> of June 2004. The contract was negotiated for 7 years, and it was decided on by the FAO-Conference in November 2001.

The agreement includes the most important agricultural cultivated plants and regulates the use of their aenetic features. The parties to the agreement mutually guarantee free access to seed and reproductive material, and they share commercial and other ad-



vantages resulting from its utilization within the frame of a multilateral system. The international agricultural research centres are part of the system; they dispose of important collections of cultivated plants from all over the world.

As many officials emphasised, a new chapter of North-South co-operation is opened with the agreement becoming effective. The contract sets standards for the regulation of a compensation of advantages between users of resources and suppliers of resources, taking into consideration the breeding achievements of the farmers in the plants' centres of origin and in diversity centres, which sometimes date back centuries.

## Refuge for Sorraia horses established

The Sorraia is a primitive Iberian horse, named for the Portuguese river near which it was discovered in 1920 by the Portuguese zoologist Dr. Ruy d'Andrade. The Sorraias' status is debated; d'Andrade believed them to be a remnant population of an indigenous wild horse and preserved them as such, but the Portuguese today treat them increasingly like a domestic breed. With the help of a Portuguese landowner family, Hardy Oelke, Germany, succeeded in establishing a refuge for these horses.

Ruy d'Andrade believed the Sorraia to have been the ancestor of the Lusitano breed. Moleculargenetic research, initiated by Oelke, proved their genotype to be unique\*). It was the Sorraia's wild behavior and instincts, compared with feral horses under similar circumstances, that convinced Oelke, a horse expert and author of specialized books and articles\*\*), of its status of a true wild horse. As he observed the Sorraias losing their wild behavior today due to the way they are kept and bred, and losing phenotypic characteristics due to Man's interference ans selections, he had been trying for years to establish a refuge for these rare horses. This became a reality when in March 2004, a group of mares and a stallion were released in the "Vale de Zebro Sorraia Horse Refuge" in southern Portugal, not far from the town of Coruche. The area is ideal, five square kilometers in size, and offers grassland as well as forest, is fenced in, and it's



isolated surrounding fenced in sections. Here. Sorraia the horses will be able to live unmolested, in a survival-of-thefittest situation - a milestone in the preservation of the Sorraia horse. rare genpool, consisting today of possibly no more than 150 head.

After the success of the first regional Balkan Fair "Agro-Biodiversity and Rural Heritage" in autumn last year, the fair will be carried out for the second time from 24-25<sup>th</sup> of September 2004 in Serbian Dimitrovgrad. ## **FAO-Meeting Rome**

At the end of March, "Intergovernmental Technical Working Group on Animal Genetic Resources" had its 3rd meeting in Rome. The participants prepared the "State of the World-Report" on animal genetic resources, which is supposed to be available in 2006. The report will base on more than 150 country reports. Interest was huge. Delegations from more than 134 countries participated in the discussion. SAVE Foundation was invited as observer.

Amongst others, it was decided that the report is to contain a part on strategic action priorities, and that a follow-up mechanism is to be created to help countries to act according to their prioritised aims. An important part of the follow-up is the set-up of "regional networks". NGOs, civil organisations and the private sector are to be integrated.
